

The goal is to improve care and Medicaid beneficiary outcomes within three practice transformation core competencies:



## **Telehealth Innovation Program**

The Department of Health Care Finance (DHCF) awarded grants to local organizations to support new telehealth services for residents in Wards 7 and 8 as well as residents of homeless shelters and public housing developments.

These projects will connect(ed) patients to specialists such as cardiologists, psychiatrists. emergency physicians and pharmacists, using interactive audio, video, or other new technology.

DHCF also awarded grants to local organizations to support telemedicine services among the District's medication-assisted therapy (MAT) network of providers, including providers authorized ("waivered") to treat opioid dependency with buprenorphine.

## TELEMEDICINE MEDICATION ASSISTED THERAPY (TELEMAT) 2021 GRANTEES





Grantees	Description
MedStar Health Research Institute	MedStar Washington Hospital Center (MWHC) in partnership with Unity Health Care, will implement LINK-MAT, a patient-centered program, embedded in the evidence-based SBIRT model employed at MWHC to address the increasing opioid-related overdose and mortality rates among DC's vulnerable and underserved populations by providing a more seamless experience of care that integrates continuing behavioral health care in the Emergency Department to improve treatment outcomes for OUD.
Howard University and Pennsylvania Avenue Baptist Church	The Better Together TeleMAT Community Partnership, a collaboration between Howard University and the DC Dream Center and Pennsylvania Avenue Baptist Church plans to provide MAT via telehealth to persons with OUD in Ward 7 and neighboring communities.
Honoring Individual Power & Strength (HIPS)	HIPS has refined a harm reduction clinical model that has been successfully replicated five times since 2016. ## TeleMAT Pilot: LINKMAT PROJECT

**Goal:** Expand upon efforts in MedStar Washington Hospital Center's ED to screen and connect patients with OUD to buprenorphine treatment. With grant support from DHCF, improve the connection to addiction treatment at Unity using telemedicine for patients in the ED.

**Method:** Established grant agreement, data sharing agreements, and BAA with Bluestream. MedStar and Mosaic Group collaborated to train hospital peer recovery coaches to discuss treatment options and obtain consent from patients with OUD interested in buprenorphine treatment during their visit.

From June to Sept 2021, Unity had a pool of on-call providers from 7am to 11pm waivered to prescribe buprenorphine. Hospital peers linked patients immediately to televideo appointment using MedStar's BlueStream platform. The patients were either dosed in the ED or instructed on home initiation of buprenorphine, and provided a follow up appointment with Unity's Opioid Recovery Program in person or via telemedicine.

## Results:



## **Objective: increase referrals for MAT:**

- Intervention: Avg. 4.25/month, (17 referrals)
- Control: Avg. 2.25 referred per month (27 referrals)



**Objective: Improve connection to first** 

**MAT** visit:

**Target:** 50 telemedicine visits

• Intervention: 82.4% (14/17): 11 received buprenorphine

Control: 44.4% (12/27)

# Objective: Improve patient retention at 30 days

•Intervention: 54.5% (6 of 11)

•Control: 66.7% (8 of 12)



## TeleMAT Findings:



## **Lessons Learned/Conclusions:**

- Lower volume than anticipated. Many patients not ready for treatment or are interested in methadone or acute detoxification. Expanded intervention to inpatient admissions.
- Poor access to consistent phone number for patients, resulting in loss to follow up. Open access hours for patients could help close the gap.
- Financial sustainability of on-call pool would be dependent on expanding the volume of referrals.
- Build provider capacity in ED and inpatient to initiate buprenorphine

## Next Steps



- Address prevention via rational opioid prescribing practices.
- Encourage ED and inpatient providers to obtain waivers.
- Expand inpatient protocol for buprenorphine inductions.
- Increase staff education to increase comfort with buprenorphine initiation and procedures.
- Expanded take home naloxone access.
- Consider methadone expansion in the ED and inpatient settings.

# Better Together TeleMAT Community Partnership



This program is a collaboration between Howard University (HU), the DC Dream Center and the Pennsylvania Avenue Baptist Church to provide medication assisted treatment (MAT) via telehealth (TeleMAT) to persons with opioid use disorder (OUD) in Ward 7 and neighboring communities. Access to TeleMAT will be available at the DC Dream Center and the Pennsylvania Avenue Baptist Church, which will serve as originating sites for TeleMAT.



(All Opioids)







Fig. 9: Number of Drug Overdoses due to Opioid Use by Ward of Residence and Year




# What's the Problem Being Addressed?

- Overdose deaths increasing rapidly in District: tripled from 2014 to 2016, then doubled from 2016 to 2020
- Overdose deaths occur predominantly among Black persons (mainly older, Black males)
- Highly concentrated in most segregated, economically disadvantaged, medically underserved communities

## Better Together TeleMAT Project Design

## Hub and Spoke Model

- MAT with buprenorphine provided via telemedicine in nonmedical community sites (spokes): DC Dream Center, Pennsylvania Avenue Baptist Church (PABC)
- Outreach/Engagement conducted by Peer Recovery Specialist (DC Dream Center) and Health Ministers (PABC)





## Better Together TeleMAT Project Design

- Peer Recovery Specialist and Health Ministers serve as telepresenters (assisting utilization of laptops, video conferencing, linkage with hub clinic buprenorphine providers)
- Patients registered for care in HU Open Access Clinic (hub)
- HU waivered providers prescribe buprenorphine
- Counseling provided by Peer Recovery Specialist and Health Ministers in DC Dream Center or PABC





# Grant Overview: Telemedicine Innovations in Medication Assisted Therapy (TeleMAT) Grant

The program sought to accomplish five objectives for the implementation, improvement, enhancement, and measurement of MAT telehealth services for District residents:

**Objective #1:** Design TeleMAT services to Align with Clinical Workflows and Evidence-Based practice

**Objective #2**: Deploy the TeleMAT Solution

**Objective #3**: Implement and Test the TeleMAT solution

**Objective #4**: Assess experience using TeleMAT to increase access to MAT services in the District of Columbia

**Objective #5**: Engage Stakeholders to Provide Patient Education

## **Successes**

- · Project Manager hired June 21, 2021
- · Other staff were hired and onboarded beginning June 2021
- · Ongoing training (GPRA, recovery coaching, NARCAN training)
- · Weekly supervision meetings with health ministers and peers to address their training needs and workflow
- Prior to the end of the grant, contact was made with over 28 businesses and organizations in the surrounding area in Wards 7 and 8
- · DC Dream Center MAT Site launched in September 2021



## Challenges

- Patients needing extensive care coordination services (housing, insurance, no ID, primary care needs)
- · Seeking long-term residential treatment
- · Superseding mental health needs
- · Process of getting prescriptions filled
- Stages of Change
- Transportation limitations
- Already receiving methadone or buprenorphine treatment



## Moving Forward

- · Ongoing community outreach
- Interview all HU providers and staff involved in provision of TeleMAT or potentially affected by implementation of the service (e.g., IT and medical records leadership; patient schedulers, etc.)
- Interview all DC Dream Center and Pennsylvania Avenue Baptist Church staff involved in project or potentially affected by it.
- · Interview patients referred to or receiving TeleMAT
